# Types of Data Collected – App Permissions

Following permissions for the app to access are required:

#### Camera:

- To scan the barcodes of segments with the camera.
- To take pictures of the segment damages.

#### SD-Card:

 The pictures of the segment damages are saved on the SD card so that they can be retrieved at any time, even in offline mode.

#### **Pictures:**

- To upload pictures of segment damages to the app at a later time.

#### Device ID & Call History:

- Security concept of the app to protect against misuse: We want to make sure, only company-issued devices have access to our app.
- TPC never accesses your calls, call history or other personal data.

#### Location:

- TPC does not access information about your location.

#### **Customer Survey:**

 The participation in the survey is voluntary. The survey allows us to evaluate your satisfaction with our app and to improve TPC.

If TPC crashes, the following data will be transferred to us (only, if you activated the option to share crash data with us, using the setting in the app settings):

- Device ID, operating system, version of the operating system and email
- $\rightarrow$  the data is evaluated statistically to improve the stability and functions of our app

#### Storage of: user name, hash of password and device ID

- This data is stored so that the user has to type his username and password for the login only once to log into TPC.
